Introduction

- A.1.4.1 This document forms Appendix 2.1 of the Preliminary Environmental Information Report (PEIR) prepared on behalf of Renewable Energy Systems (RES). The PEIR presents the preliminary findings of the Environmental Impact Assessment (EIA) process for the construction, operation, and decommissioning of a ground mounted solar photovoltaic (PV) electricity generation with an approximate capacity of 450 MW of energy generation and associated development comprising 150MW of energy storage and grid connection infrastructure (herein referred to as 'the Proposed Development').
- A.1.4.1 This document provides the locations in which the PEIR addresses the requirements of Schedule 4 'Information for Inclusion I Environmental Statements' of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017.
